Don't Be A Lazy Pilot...

In June, the *Summit of the Americas* was being hosted in Pasadena, California. Among the attendees were the President and Vice President of the United States. For pilots in the southland, because of what was going on, there were four or five active Temporary Flight Restrictions (TFRs) in our area over the course of three days. Normally, when a TFR is posted, it isn't really that big a deal around CCB; however, during this period of time, pilots from CCB violated the TFRs not once but *THREE* times. This not only was brought to the attention of

the United States Air Force it was also noticed by the Federal Aviation Administration (FAA) so much so that the Airport Office received three very angry calls from the FAA Virginia office monitoring the TFRs making sure that the aircraft in question returned to CCB as soon as possible. On one of those occasion, the pilot had to talk with the Secret Service because of the blatant violation. The point to this article is don't be a lazy pilot. Take the time to review any NOTAMs and/or TFRs that may be applicable. In this particular case, it was obvious the pilot had been lazy and not taken the few minutes it takes to see if there are TFRs present and/or if any NOTAMs existed. Don't be THAT pilot!


sorties to train for real-world emergency services missions. Nearly 60 CAP members from all over Southern California participated in the exercise.

Civil Air Patrol is the auxiliary of the United States Air Force, consisting of nearly 56,000 members and operating the world's largest fleet of single-engine piston aircraft. In its emergency services mission, CAP is tasked



with about 90% of continental U.S. inland search and rescue by the Air Force Rescue Coordination Center and is credited with

saving an average of 78 lives annually.



EAA VMC Club Question of the Month – Answer

The proposed flight would not be strictly against Federal Aviation Regulations as long you maintain the required altitudes as prescribed in FAR 91.119, Minimum Safe Altitudes. AC-

91-36D states that noise-producing aircraft over noise-sensitive areas should make every effort to fly not less than 2,000 feet above ground level (AGL), weather permitting. It also defines wildlife refuges as noise-sensitive areas. It is recommended that pilots observe the 2,000' AGL minimum altitude. However, flights below 2,000' AGL over such areas are not strictly prohibited.
