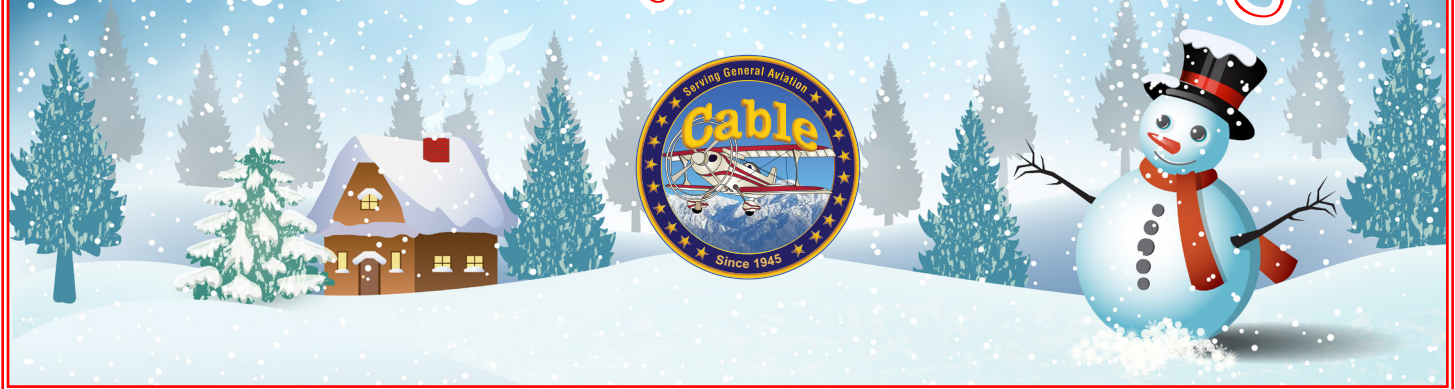

## *Bits and Pieces*

### **What will it take to have CCB survive? (Correction)**

Last month, the Cable Gram had an article that covered some of the things that it will take to keep CCB an airport. This article sparked a couple of tenants questioning the use of certain hangars.

In that article, it was mentioned what it takes to keep CCB an **ACTIVE** general aviation airport with **ACTIVE** aircraft with **ACTIVE** pilots. While what was written is true, what the article didn't explain is that both the FAA and CCB consider any businesses operating out of hangars that **SUPPORT** general aviation activities qualify. CCB has a number of businesses meet this requirement such as an aftermarket GA engine fuel injection system manufacturer, a couple of aircraft upholsters, a GA aircraft propeller balancer, and a few A&P mechanics. These businesses bring GA to CCB and that is why they are allowed.

### **Extended Parking in the Taxiways is Not Permitted**

It is not uncommon to see vehicles parked in the taxiways. Many vehicles are parked a lot longer period than the 15 minutes allowed and, sometimes, vehicles have been parked in the taxiway in front of someone's hangar for days on end.

While many are aware of when a plane is taxiing by their hangar with most willing I do their best to move their vehicle, there have been many occasions where the owner of the vehicle can't be located. This is a bigger problem on the narrower taxiways. And it can be a larger problem if the owner of the vehicle has decided to leave the vehicle throughout the evening.

Parking in the taxiway can hinder the movement of the aircraft trying to taxi from one point to another. Please understand that pilot skill levels vary. Some pilots can whip their aircraft in and out of the taxiways between the vehicles while other get extremely nervous and prefer not to have to do so.

Unless other arrangements have been agreed upon, when you rent your hangar you are only renting the space in the hangar. You are not renting space on the taxiway, nor the transient parking spaces, nor any other location on the field.

And finally, as a reminder, the marked transient parking spots are for day use only. Unless authorized by the Airport Office, vehicles parked longer than 24 hours in a transient parking spot will be tagged and subject to tow at the owners expense.

The \*L indicates that lighting limitations exist, and you need to refer to the Supplement. Normally, pilot-controlled lighting (PCL) is activated via the CTAF. However, the Supplement may indicate a different frequency for activating the PCL or some other limitation of the lighting system.

### Be Prepared for the Rainy Season

With all the rain that we received and in case there is potential for more it is good to keep in mind that you may find it useful because of leaking hangars to have access to sandbags.

The City of Upland has a limited supply of free sand and sandbags available to its residents to assist in protecting their properties from storm-water run-off and possible flooding.

Sandbags are available across the street at:

Hours of Operation:  
Monday - Thursday (7 a.m. – 6 p.m.)  
Saturday - (9 a.m. – 2 p.m.)

#### Sandbag Guidelines:

1. Must be an Upland resident.
2. Shovels are available for self-service use.
3. Fill sandbags 1/2 to 2/3 full and tie at the top so the bag will lay flat when put in place. A properly filled sand bag should weigh between 35-40 lbs.
4. Bring someone to assist you. It is important to note that filling sandbags is a two-person job.

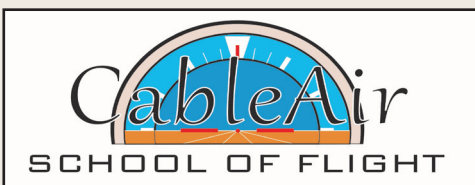

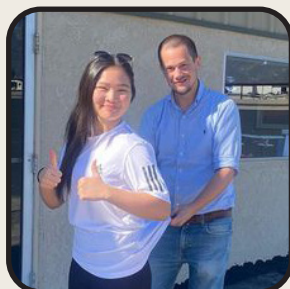
