

# Tropical Storm Hilary a Bust at CCB

There was a lot of press about tropical storm Hilary which actually grew to a Category 4 hurricane, which is significant; however, by the time it made landfall in California, it was downgraded to a "tropical storm." While a tropical storm has the ability to do severe damage, based on the track of Hilary, it was business as usual particularly at CCB though, we will admit, it caused calamity in other parts of the region. Thankfully, there was no reported calamity in our region.

CCB's Automated Weather Observation System (AWOS), which is an official National Oceanic and Atmospheric Administration (NOAA) weather station, recorded 2.17 inches in rain over a period of 24 hours. The system also recorded sustained winds of up to 12 knots with gusts reaching 20 knots during the period that Hilary passed through. While the amount of rain received during the 24 hours was a lot for CCB, it wasn't anything that hasn't been experienced at CCB within the last 12 months. The winds were considered normal as winds of up to 15 knots are recorded regularly during the afternoons of a "normal" day. And CCB has recorded much higher gusts during Santa Ana conditions.

All-in-all, CCB faired quite well during Tropical Storm Hilary which we are thankful for.

## Your Updated Information Is Needed

Many times when we go through our files, we notice that the information we have on record is out of date and/or has expired. Many times it is simply a change of address or telephone number that is needed; however, most often, it is the insurance certificate that has expired.

It is a requirement of your lease to have up-to-date insurance. Many times, asking your insurance company to list Cable Airport as an "additionally insured" will solve the problem. This allows the insurance company to send up-to-date insurance information directly to us; however, if you have switched insurance companies, they may not have the Airport listed. The Airport Office asks that you follow up to make sure we have your current mailing address, telephone number, email address, and insurance certificate.

Please remember that communication is key, so your help in keeping the Airport in the loop is greatly appreciated and shows that you are also meeting the requirements of Section 9 of your lease. Thank you!

### EAA VMC Club Question of the Month – Answer



Although the pilot is not intending to land and is lined up not with the runway but beside the runway in use, it should still be considered "landing" for purposes of right-of-way.

According to AC 90-66C, Para 8.2.2.1, "An aircraft in the traffic pattern of an airport is considered an aircraft approaching to land at the airport."

It is important to take precautionary measures when we just have to fly whether it is for training or the need to get somewhere. 
